LOAVES & FISHES

On August 2, Diane Ramonas was
our speaker. Diane is the Community
Relations Manager for Loaves &
Fishes. Loaves & Fishes is a local
food pantry that was started in a
small closet at St. Raphael 32 years
ago.

They have continued to grow and in
2011, moved into their new facility.
This new building was formulated to
aid in the dignity of those it serves. It
houses a client-choice market and
space for a variety of other
programs.

In the program space, Loaves &
Fishes works in conjunction with
College of DuPage to offer English
as a Second Language classes.
They also host job counselors and
help clients apply for food stamps
and other types of aid. Each year
they also help with income taxes.

Loaves and Fishes recently merged
with Naperville Cares to combine all
of their resources under one roof.
Naperville Cares is an organization
that provides emergency funding to
people in need.

Clients can come and receive food
once every 14 days at Loaves &
Fishes. About two-thirds of the food
available has been recovered from
local supermarkets. The staff picks
up food from the supermarkets and
inspects everything and usually gets
it onto their shelves within 24-48
hours.

Loaves & Fishes is a member of the Northern Illinois Food Bank. This allows them to buy food for about ten cents on the dollar.

They partner with the post office and their annual food drive. Loaves and Fishes receives all of the food collected in Naperville. Their volunteers help to collect and sort. Last year they collected over 80,000 pounds of food. It took more than one month to sort through it all.

The client-choice model that Loaves & Fishes utilizes is unique. When someone is picking up food from their pantry, they walk through just like a regular supermarket. They are allowed a certain number of items per category and get to choose what they actually take home with them.

Loaves & Fishes also provides delivery to certain senior citizens and disabled clients who cannot get to the market themselves. The deliveries come once per month.

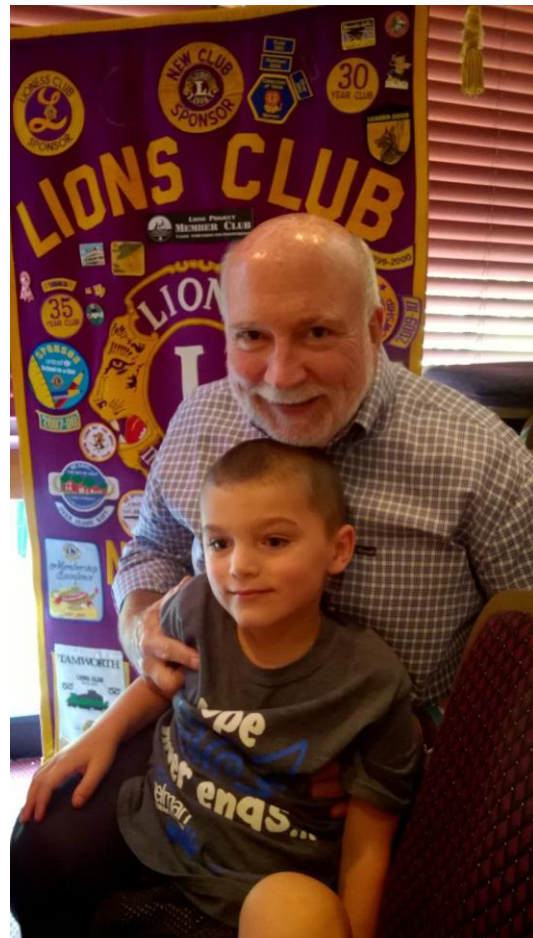
Loaves and Fishes has 18 people currently on staff. They have hundreds of volunteers that deliver the majority of their services. Last year, the volunteers dedicated 85,000 man hours to the organization. With that kind of support, Loaves and Fishes is able to use 96% of its funding for client services.

### **JULIE & GAVIN**

On August 9, our club had many very special guests. A large contingent of Lion Al Knotek's family

was on hand with Eileen Braun from the Angelman Syndrome Foundation. Al's wife, Glenda, and daughters Julie and Stacie were guests along with their children, Connor (7), Lauren (7), Gavin (5), Matthew (5) and Audrey (3).

Julie's son, Gavin, was born with Angelman Syndrome and the two of them were making a presentation to the club to provide a glimpse into their family's life and the various obstacles that they have overcome and some that they still face on a daily basis.

Julie spoke about how, in March of 2013, she and her family were

quietly going through a struggle with Gavin as he was not progressing as expected developmentally. He was tested over and over again by a great many doctors. At this time, he was two and a half and was not sleeping through the night. No one was providing any answers or diagnoses for their situation.

In March, 2013, they travelled to the Mayo Clinic where Gavin was tested for Angelman Syndrome. After a one month wait for results, they received the news that his test was positive. At that point in time, Eileen had just spoken to our club about the Angelman Syndrome foundation. Upon learning about the organization, Lion AI directed Julie to Eileen.

Julie and her husband needed help because Angelman Syndrome is not very common. They were introduced to a program with a set of specialist in Boston. The family travels to Boston now about once per year. While in Boston, Gavin gets to meet with a number of specialists who are very familiar with Angelman Syndrome. He visits with a neurologist, a sleep specialist, a psychologist, and a gastroenterologist. They stay in Boston for three or four days at a time.

Gavin faces a number of hurdles as a result of Angelman Syndrome. He is unable to verbally communicate like other children, however he is good at saying "Mama." He has a great deal of trouble sleeping at night and needs to take medication to account for that. He is also very

anxious when he is out in public. Julie was worried about how Gavin would adapt to the Lions Club environment, but she was happy to see Lion Meghan Williams arrive as she acted as a calming force for him.

Julie described how every day is full of therapy for Gavin. He goes to speech therapy and is making improvements. He loves to swim and was very excited that he and the rest of the crew were spending the afternoon swimming after our meeting. He is also a big fan of jigsaw puzzles.

Julie marveled at how compassionate and mature her other two children are because of Gavin. She calls them his greatest teachers and examples.

Overall, Gavin has made great strides since his diagnosis. Julie and her husband continue to push him each and every day because they know no limit to what he can achieve. Thus far, he has risen to the occasion every time. Thank you to Lion AI and his entire family for a very memorable and enjoyable meeting.

## **BOARD HIGHLIGHTS**

The Board of Directors met on August 23, 2016 at Beidelman-Kunsch Funeral Home in downtown

Naperville. The following is a summary of the Board's actions and discussions. All members are welcome to attend the Board meetings, which start at 7:30 a.m. the next Board meeting will be held on September 26, 2016.

Approved the Club and Foundation Board minutes of July 28, 2016.

Approved the Treasurer's Report as of July 31, 2016 and the Social Service Report as of August 23, 2016. Fifteen new cases were opened in August. Expenditures for July totaled \$7,313 for 23 closed cases.

Approved the full membership of James Baird.

Discussed the possibility of inviting Stephanie Penik, Editor of Positively Naperville, to draw the winning tickets for the Summer Raffle on September 6<sup>th</sup>. Bob Hull will contact her to see if she is available.

Discussed the Summer Raffle. \$23,000 have been collected which is approximately \$6,000 ahead of last year at this time. The goal is to reach \$30,000.

Discussed Candy Day which will be held on October 7 and 8 this year and the possibility of increasing the locations to distribute candy mints and increasing the number of volunteers to participate.

Discussed Turkey Trot. At this date 238 individuals have registered. Cash collections from sponsors is approximately \$15,000 which is

about half of our goal. Also discussed the changes that are being made in our CETA grant from the City of Naperville and its effect on future Turkey Trots.

Discussed possible grant to People's Resource Center. No action was taken.

Approved adding four links to the Clubs web-site regarding guides containing information pertaining to assistance for blind, low vision and hard of hearing individuals and deleting one link pertaining to crisis management which did not meet the Lions mission.

Reviewed the plaque related to the Bob Anderson Lifetime Service Award which will be given to the widow of the Late Ollie Burrows.

Approved the Club's support for the Naperville Marathon. The Club will provide volunteers to monitor a portion of the race route. Ten volunteers will be needed and we will be able to display information regarding our Turkey Trot on Thanksgiving morning.

Discussed NCTV – 17 taping of "Spotlight on Naperville". Lions President and one other Lion will appear on the show which will be taped on October 12<sup>th</sup>.

Discussed membership in the Naperville Chamber of Commerce. It was the consensus of the Board not to become a member of the Chamber.
