## Luncheon Speakers

### CHILD'S VOICE

On April 3, Kate Bossum returned to our club to talk to us about Child's Voice. Kate is the director of advancement for Child's Voice, a school for children with hearing loss.

Child's Voice helps children learn to listen, speak, sing, and succeed. They work to empower the children. They accomplish this goal through three main programs.

The first is the audiology clinic. This clinic is for babies during the first 18 months. They do diagnostic testing and newborn hearing screenings as well as any follow up care.

The next is the early intervention program for ages birth to three. They work with parents to provide home-based support and two group services at the school.

Last is the school program for children ages 3-8. Our club visited the school last year and was able to participate in some activities with the kids and see the school first hand.

This is a classroom style program. Children come from over 30 school districts. The instructors are experts and focus on learning through play. The goal is for each child to graduate and move onto the mainstream school program within their home district.

The program is paid for by the child's home school district. By enrolling in this program instead of receiving a bevy of other accommodations at their home school district, the school district saves approximately \$350,000 per child.

Kate has invited our group back to visit again and wants to keep making connections with other service organizations and clubs. She stressed that their biggest hurdle is outreach and awareness.

### **FAMILY SHELTER SERVICE**

On April 10, Mary Beth Glenn and Dawn were our guest speakers from Family Shelter Service. Family Shelter Service was founded in 1976 with a network of homes and a hotline. They eventually built a shelter in Downers Grove, which now has 41 beds.

The shelter operates for victims of domestic violence. While at the shelter, individuals receive services from the organization. These include counseling for both parents and children.

They also operate two resale shops, called Second Chance Resale, in Naperville and Westmont. These stores offer a fundraising arm as well as a place for clients to shop when they are ready to move out on their own again.

Family Shelter Service continues to operate a 24/7 hotline that took 12,300 calls in 2017. The hotline is operated by both employees and volunteers who have received domestic violence training. They can offer immediate assistance to callers.

Last year, Family Shelter Service provided 12,098 nights of shelter. Despite that, there is always a waiting list and many people are

turned away. The Downers Grove shelter recently added a suite to accommodate male clients apart from the females.

**DUPAGE LEGAL AID**

Cecelia Najera, the director of DuPage Legal Aid, was our guest speaker on April 17. DuPage Legal Aid offers primarily family law legal services to DuPage County residents who cannot afford an attorney. The organization was founded by members of the DuPage County Bar Association who saw the need for free legal aid.

The majority of the legal work is done by volunteer attorneys throughout the county. DuPage Legal Aid has two staff attorneys, but more than 400 local attorneys who agree to take cases on a pro bono basis.

DuPage Legal Aid also offers free legal clinics at Loaves and Fishes and Family Shelter Services. They assist domestic violence victims with orders of protection.

In order to qualify for services, the client cannot make more than 150% of the poverty level, which for a family of two in DuPage County is approximately \$28,000. They will move that number to 275% of the poverty level for special circumstances. There are 600-700 cases open at any given time. Last year, they were able to provide 10,800 hours of pro bono legal service to the community.
