## **Luncheon Speakers**

### **HESED HOUSE**

Rebecca Einhaus was our guest speaker on July 2. She is the marketing and communications director for Hesed House, the second largest homeless shelter in Illinois.

Hesed House was opened in 1986 by six churches in Aurora. Today, they focus on three core programs. They have an overnight shelter, a day program, and a family shelter.

The overnight shelter is open from 7:00 PM to 7:00 AM for adult men and women. They provide dinner, laundry, showers, and a place to sleep. The day program acts as a heating/cooling shelter and provides different services, like haircuts and job skills. The family shelter is the newest addition. This is for families only and provides specialty programs for family units.

Hesed House employs case workers to work with all guests. Volunteers serve three meals every day at the shelter. Across the street from the shelter is the Comprehensive Care Center providing additional services to the guests with an aim to get them out of homelessness.

In November, they started a new initiative called the Harbor. This program is directed at chronically homeless individuals. They provide stability by placing these individuals into dorm-like housing. The first four participants had a combined 100 years of homelessness. This

program has had positive results so far.

Every year, Hesed House helps over 1,000 people. They are a low-threshold shelter, only restricting access to sex offenders. They serve dinner to 125-170 people in the summertime, but more in the winter.

### **CURE SMA**

On July 9, Kathy Heinrich was our guest speaker from Cure SMA. Kathy is a fifth-grade teacher in Plainfield whose son was born with Spinal Muscular Atrophy (SMA).

SMA is the top genetic cause of infant death. It is caused by the lack of a protein that fuels motor neurons. The signal is lost causing the muscles to atrophy. Most pass away by the age of two. One in fifty people carry the missing gene and both parents need to carry to pass it on.

Cure SMA is a national organization based in Elk Grove Village. They work with families of children with SMA. They provide information to parents as well as organize conferences where other families can get together.

There is currently a great deal of research and testing of possible treatment options for SMA. In the last few years, two drugs have been approved that help stop the progression of SMA. Many other are still in development.

Kathy's mission is to raise awareness about SMA. She has

even worked with her state house representative to include SMA testing on the newborn screening panel. This was successful and will be added in 2020.

### **BOB BERLIN**

DuPage County State's Attorney, Bob Berlin was our guest speaker on July 16. Bob has been a prosecutor for 31 years and was appointed as the State's Attorney in 2010.

He reported that DUIs and Misdemeanors are down, but felony indictments are up. He stated that more than half of the felony indictments are against out of county residents.

Bob's office has worked to combat the opioid epidemic by providing treatment to certain offenders over jail. He tried to put nonviolent offenders into the drug court program which allows the offender to complete certain obligations and eventually have their cases reduced or dismissed entirely.

His office is committed to being very aggressive with drug dealers. He is even charging some with drug induced homicide when someone overdoses on that dealer's drugs. This is Class X felony with a possible sentence of 6-30 years.

The State's Attorney's office also helps collect unpaid child support. His unit is made up of four attorneys in one courtroom. Last year they brought in over \$40 million in unpaid child support.

### **PAUL ABELSON**

On July 23, Paul Abelson was our guest speaker. Paul is a former journalist in the trucking industry. He started his career in trucking in the advertising and marketing sector. He became very involved in the trade organizations, which were the main source of information exchange.

In Paul's time in the trucking industry, he worked on safety regulations and fuel economy. He was involved in the red and white tape seen on all trucks now.

Paul informed our group that truckers are the safest drivers on the road. 75% of accidents involving trucks are the fault of the other driver. He also told us how driving hours are limited to improve safety.

### **JULIE AND GAVIN STAAB**

Julie Staab and family made their annual visit to our club meeting on July 30 to give us an update on her son Gavin. Julie is Lion Al Knotek's daughter and Gavin has Angelman Syndrome. Julie and Gavin have been coming back year after year and the club has gotten a chance to see how far Gavin has progressed.

The Angelman Syndrome Foundation has been a big help to Gavin's family. They have helped to direct Gavin into the right medical care. Each year, Gavin travels to Boston to be seen by a group of medical providers specializing in Angelman Syndrome. Recently, a

clinic was opened in Chicago and they are going to visit there next.

Gavin has made tremendous improvement since he last visited the club. He uses his talking device to communicate along with modified sign language. He can sight read about 100 words now. During the summer he spends part of each day learning with his brother and sister, who have both been a big help and role models for Gavin.

Gavin is able write his first and last name, something the doctors said he would never be able to do. He goes to private therapy each week and does therapy in school as well.

Gavin is entering the third grade this year. At school he has a full-time aid with him. About half of his time is spent with the typical classroom and the other half is spent in special education.

Outside of school, Gavin does much of what a normal eight-year-old does. He likes to swim and fish. He likes to play games and watch YouTube videos.

Gavin has inspired our club to get involved with the annual Angelman Syndrome Foundation walk at the Lisle location. As Julie and Gavin live in Iowa, they have taken on the challenge of starting a new walk location in Bettendorf, Iowa for 2020.
