**Luncheon Speakers**

**DUPAGE STATE'S ATTORNEY**

DuPage State's Attorney, Bob Berlin, was our guest speaker on September 5. He also served as the raffle drawer for our summer raffle. Bob was on hand to give the club a public safety update.

Bob informed the club that while felony indictments in DuPage county had been decreasing, they were on the rise in 2022. He did note that 60% of the felony defendants do not live in DuPage County.

He talked about the various diversion courtrooms that DuPage County has

created, including drug court and focus court. These courtrooms offer an alternative to the traditional criminal justice system for first-time and nonviolent offenders. It offers a treatment program to hopefully curtail any criminal behavior in the future.

Bob discussed the new elimination of cash bail, created by the Pretrial Fairness Act, which covers individuals who have been charged with a crime, but have not been convicted of said crime. This system went into effect in late September and he was hard at work implementing systems so that he could ensure that dangerous defendants remain in custody.

**MAYOR SCOTT WEHRLI**

On September 12, we were honored to have newly elected Naperville Mayor Scott Wehrli as our guest speaker. He indicated that he grew up in Naperville and comes from a long line of Wehrli family members who have served the Naperville community, but he is the first Wehrli to be elected Mayor. After listening to all of the activities of the NNLC prior to his remarks, he described the Club as "Small but Mighty".

He indicated that his approach to being Mayor is to have lots of energy and wants to move ideas and issues faster than is normal for government operations. He has established a three-minute clock, in the council chambers, for those individuals wishing to speak at council meetings that they do not exceed their allotted

time and that staff and other officials are addressed by their professional titles rather than by first names. He also wrote a book of guidelines for government boards and commissions so as to help understand how the city works.

Priorities for his first term in office are to address youth mental health, economic development, government transparency, and public safety. He has established a committee to address mental health training for high school students. He also indicated that a new system to track crime called “National Incident-Based Reporting System” (NIBRS) has been established. This is a system that captures detailed data about the characteristics of criminal incidents. Naperville is not crime free, but is a safe place to live, he stated.

He addressed some areas and projects he is excited about. Namely, the Shuman, which is a 360,000 square foot office complex located at 263 Shuman Blvd. and HUB 1415, which is a 75-acre office campus located at 1415 Diehl Road. Both complexes afford sufficient opportunities for high-end companies to relocate to Naperville. He also mentioned the Nokia property (formerly Alcatel-Lucent Campus), which is being sold. Nokia, which employs over 1,000 workers, will stay in Naperville, but the property will be redeveloped. He stated that careful long-term planning needs to be considered so that too many warehouse facilities are not constructed on this property as opposed to office or entertainment

facilities. He stated this may be a location for the Chicago Bears football team.

There are also many opportunities for development in the district west of Route 59 and what he called Block 59. More retail space is needed, especially in the sale of apparel and furniture. He also discussed downtown Naperville and its two recent new businesses, Ramsey Kitchen and Sweet Cream robotic restaurant. Other developments discussed included Main Street Promenade Phase III and River Main Development at Water Street. He indicated that Naperville is the 4<sup>th</sup> largest city in Illinois, but has the 2<sup>nd</sup> largest economy. Its hospitality industry is 2<sup>nd</sup> only to the City of Chicago.

After he concluded his remarks at the Lions Club, he was going to put on his uniform and put in some time as a Lieutenant with the Naperville Park District Police, which he has been doing for over three decades.

### **ST. JUDE CHILDREN’S HOSPITAL**

Danielle Reeves was our guest speaker on September 19 to talk with us about St. Jude Children’s Research Hospital. St. Jude was founded by Danny Thomas, who had a passion for children. He wanted to establish a place for children from around the world to come and get treatment, as well as for research – all at no cost to the child’s family.

Founded in 1967, it took Thomas five years to raise the funding to build the

first building in Memphis, TN. Since then, they have expanded a great deal, making up an entire campus.

They have four housing facilities for families to stay at while their children are receiving treatment. These are apartment-style homes to provide a sense of home and respite from the hospital. Most of the patients go to the hospital for treatment during the day and return to the on-campus housing facility for evenings away from the hospital.

St. Jude is unique in that it has everything the patient needs on campus. They have teachers on staff who work in conjunction with the child's home school to make sure they do not fall behind in class. They also have other medical providers available on campus to treat ancillary concerns that may arise.

Danielle talked about the aid that St. Jude has provided globally. They have provided \$200 million in cancer medications around the world. Childhood cancer is treatable and largely survivable, but only if the child has access to care. This is, unfortunately, not the case in many parts of the world. In addition to aid, St. Jude shares its research and treatment protocols with the medical community throughout the world for free.
